Dear Ms. Rehbinder,

the ensurance of fair competition and protection of EU companies from interferences with trademark and competition rights is one of the key objectives of GD COMPETTION. I am therefore writing to you today to request for a meeting between the Coalition of the Fine Paper Industry and the Commission experts in GD COMPETITION involved in the revision of the Tobacco Product Directive (2001/37/EC). I am, of course, aware that the major responsibility for the revision lies with GD SANCO. However, given that other GDs involved in the discussions on the revision have obviously raised concerns regarding the proportionality of some of the measures envisaged by GD SANCO, the possibility for a meeting would be greatly appreciated.

In recent months, I have been in regular contact with representatives of the tobacco industry who have informed me about their concerns regarding some of the plans by GD SANCO. Particularly with a view on the potential introduction of the socalled "plain packaging" I share these concerns. The idea of plain packaging does not only constitute a massive encroachment on trademark and competition law and rights, but would make it even easier for criminal organizations to copy tobacco products thus further increasing illicit trading. Such a development would not only jeopardize the health of tobacco consumers due to potentially unsafe ingredients, but would lead to massive tax deficits and endanger jobs. Particularly SMEs, who supply the big tobacco producers with raw materials and fine paper, would be severely hit by the expected loss in market share. In my constituency, 400 jobs in a company producing cigarette and plug wrap paper, would be in danger.

The coalition for fine paper industry represents SMEs from Germany, Austria, France, Great Britain, Poland and Spain. Spokesperson of this coalition is the Deutsche Benkert GmbH, a company that produces 200 billion tipping papers every year and is a global partner of the tobacco industry. In light of the negative effects that have to be expected from overregulation on many jobs in Germany and other European member states, I would be grateful if you or the responsible expert in your unit would find the time to meet with the director of Deutsche Benkert GmbH, Mr. Arnd Brinker.
